Self-Declaration Form for Multi-Unit Residential Complex

As part of its commitment to reduce electricity cost pressures, the Ontario government is removing the Debt Retirement Charge (DRC) from residential electricity consumers' bills after December 31, 2015. If you have a general service-rate class account, you may be eligible for a DRC exemption of up to 1,500 kWh per month multiplied by the number of eligible residential units included in the account, if the account provides electricity to "eligible residential units".

Customers with a multi-unit residential complex can self-declare their eligibility for the Debt Retirement Charge Exemption if they qualify. Please return this completed form as soon as possible to register your account so that you may receive the exemption from paying the DRC for the first 1,500 kWh of electricity used per month per eligible residential unit. This exemption applies only to electricity consumed on or after January 1, 2016. Declarations received after that date will be applied to the next bill and not applied retroactively.

Step One - Does your account qualify?:

As defined in Ontario Regulation (O.Reg. 493/01), you qualify for DRC reduction if your account relates to an eligible residential unit that:

- (a) is a self-contained set of rooms located in a building or structure,
- (b) contains kitchen and bathroom facilities that are intended for the use of that unit only, and
- (c) is used or intended for use as a residential premises.

You must advise North Bay Hydro promptly in writing if your account ceases to qualify for the Debt Retirement Charge exemption as an eligible multi-unit residential complex or if there is a change in the number of units with the property or complex. Failure to do so will lead to the requirement to reimburse any Debt Retirement Charge exemption credit outside of the eligible time frame. Please complete the applicable sections below.
